TERMS AND CONDITIONS OF RENTAL AGREEMENT

1. **RENTAL AGREEMENT** - The customer agrees to pay for any damage to the machine, or loss of any parts, as an insurer, regardless of cause, except reasonable wear and tear, while goods are out of the possession of Aetna Plastics. The customer also agrees to pay a reasonable cleaning charge for a machine returned dirty. Accrued rental charges cannot be applied against the purchase or cost of repair of damaged or lost goods. The cost of any repairs to the machine or to its parts will be borne by the customer, whether performed by Aetna Plastics, or at Aetna Plastics' option, by others.
2. **FREIGHT** - All freight and shipping charges for equipment from Aetna Plastics' Valley View, Ohio warehouse to customer, and from customer to Aetna Plastics' Valley View, Ohio warehouse will be borne by the customer.
3. **RENTAL RATES** - Billing begins upon receipt of machine and continues up to, and including, the date returned (not including shipping days). All rentals are reported in Days, with the rate dropping for extended use. Rentals in the field in excess of one month will be billed at the end of each month. Failure to return the equipment will result in additional billing for cost of said equipment.
4. **INSPECTION** - At the time of rental, an Aetna Plastics employee will personally inspect the equipment to make sure it is suitable for the customer, in good condition, without defects, report any existing damage and review this information with the customer. An Aetna Plastics employee will again inspect the condition of the equipment upon return, review any damage which occurred during the rental period and bill accordingly. Customer acknowledges that he/she has an opportunity to personally inspect the equipment, and finds it suitable for his/her needs and in good working condition.
5. **REPLACEMENT OF MALFUNCTIONING EQUIPMENT** - If the equipment becomes unsafe or in disrepair as a result of normal use, customer agrees to discontinue use and notify Aetna Plastics, who will replace the equipment with similar equipment in good working order, if available. Aetna Plastics is not responsible for any incidental or consequential damages caused by delays or otherwise.
6. **HOLD HARMLESS AGREEMENT** - Customer assumes all risks and liabilities which may result from the use of any material, whether used singly or in combination with other products and holds Aetna Plastics harmless for any possible property damage and/or personal injuries caused by the equipment.
7. **PROHIBITED USES** - Use of the equipment in the following circumstances is prohibited, and constitutes a breach of this contract.
 - a. Use for illegal purpose or in illegal manner.
 - b. Use when the equipment is in bad repair or is unsafe
 - c. Improper, unintended use, or misuse
 - d. Use by anyone other than customer without Aetna Plastics' permission
 - e. Sublease or loan equipment without approval of Aetna Plastics
