Zeus Industrial Products, Inc. is dedicated to serving you by providing high quality fluoropolymer tubing that meets environmental regulations, including EC directive 2011/65/EU and REACH (Registration, Authorization and Restriction of Chemicals, European Union Regulation (EC) 1907/2006). We are providing you the following information to assist you in meeting your environmental policies and procedures. Please be aware that Zeus Industrial Products does not perform any specific analysis in order to detect the presence of RoHS or REACH listed materials. In addition, Zeus Industrial Products does not intentionally use these ingredients in the manufacturing of our products.

RoHS Compliance

The item listed in “Attachment A” is compliant with RoHS Directive 2011/65/EU. RoHS Compliant means that the substances restricted by the EU directive are not contained in a finished product above threshold limits stated below unless the restrictive substance is subject of an exemption contained in the RoHS directive.

REACH Compliance

In June 2007, the European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) entered into force. This Regulation establishes specific duties and obligations on companies in the European Union (EU) that manufacture or import substances on their own, in preparations, or in articles.

Under the structure of REACH regulations, Zeus Industrial Products and Zeus Industrial Products Ireland Ltd. are a manufacturer and supplier of “articles”. We do not manufacture or supply “substances” and our articles do not involve the “intentional release of substances”. Also, we continuously monitor our suppliers for the use of substances of very high concern (SVHC), as defined by REACH, in our raw material and products.
