- *ASTM C1147* – Our welders are certified in this standard for tensile weld strength. They are required to submit test samples to an independent testing laboratory for specific materials, as required.

### **Quality and Integrity**

Aetna Plastics is *ISO 9001:2008 compliant*. Our Quality Manual highlights the procedures we have put in place, including:
